The main focus of the thesis is devoted to a relationship between two variables, the economic growth and consequences of the terrorist attacks. The former can be expressed either in foreign direct investments, technological development, population growth, inflation or unemployment rate. The terrorist attack outcomes may be viewed in terms of number of death causes, injuries/wounds, property damage or just simple occurrence of such acts. The thesis assesses the (negative) effect of the terror acts on the economic growth over the period 1970-2017 using quarterly data for OECD countries.

Contribution

The author uses a data set from an exceptionally long period, which makes this study quite likely the largest panel data model in the current literature on this topic. The key findings of the thesis are the following: the occurrence of the terrorist attack itself does not have any significant effect on economic growth; the deaths resulting from terrorism affect the economic growth rate both immediately and also over the course of the next 10 quarter-years, initially negative which then turns positive; on the other hand, wounds have initially positive effect which later turns negative; in the period before 9/11 attack, the initial effects are more negative than in the period after 9/11 terrorist attack.

Majority of the authors results are original and illuminative and I am convinced that an edited version of the manuscript could be published in a suitable impact factor journal.

Methods

The main methodology used in this thesis is the panel data analysis. The theory of the standard methods are briefly described and the author subsequently comments on a particular choice (in favor of the fixed effects model). The used methods are appropriate for a student in the final year of bachelor studies at IES.

Literature

The author provides adequate list of relevant literature, focusing mainly on peer reviewed literature sources (books or papers in respectable journals). I personally do not favor point-number style to state the volume and issue of the journal, but besides that, the list of used references follows a flawless citation style.

Manuscript form

The thesis is written in flawless English. The manuscript is well structured and the author builds up the topic and provide smooth transitions between the main sections of the thesis so that the reader can proceed quickly to the main results. The text is well ballanced with reasonable number of tabullars and (illuminative) figures. Mathematical formulas are skillfully written in LaTeX which contributes positively to the superiority of this academic text.
