### Contribution

The thesis has a clear contribution regarding the current situation on market for residential property in Prague where the prices have been soaring during last couple of years. And at the same time, Airbnb and similar platforms of the sharing economy have become much more profound worldwide, not excluding Prague. Given these facts, the topic of this thesis is up to date and the author has done a very good job in taking a more rigorous approach to analyse the impact of Airbnb listings on soaring prices of residential property which is commonly presumed, but not yet too deeply analysed.

### Methods

The author has conducted the analysis on a unique dataset which she put together from various sources. One suggestion I would have to this part is that maybe in the section describing the Airbnb dataset provided by Mr. Nedvěd should be described more clearly, how the data were collected. (Maybe it could also be considered to provide short paragraph describing how the Airbnb platform works to clarify it for a reader who had never used it so far.) However, I strongly appreciate the effort put into creation of this dataset which allowed her to use the hedonic regression which is a common approach for assessment of the underlying factors influencing the housing prices. As an estimation approach, she uses OLS, which is perfectly fine for the bachelor thesis. However, if author plans to continue with research in this field in her further studies, I would recommend her to consider using other estimation approaches, such as generalized method of moments (GMM) which may be a solution to problems she mentions in her thesis, e.g. endogeneity or heteroscedasticity.

### Literature

The author has provided an overview of previous studies divided into studies concerning Czech Republic and foreign studies. The cited literature is relevant to the topic and given the fact that Airbnb and similar platforms are still relatively new phenomenon the scope of provided literature review is sufficient.

### Manuscript form

The thesis is well structured and well formated. I would only recommend adding a numbers of chapters to numbers of figures and tables, e.g. first table in chapter 4 should be named Table 4.1, second table in chapter 5 as Table 5.2, third table in appendix A as Table A.3.

- 1) Could you please provide some more inside how the dataset provided by Mgr. Adam Nedvěd described on pp. 23-25 was obtained from the Airbnb website?
- 2) On pp. 31-34 you describe the estimated model and the variables are estimated in logarithms. However, I did not find a clear explanation for this. You only write on p. 33 "The dependent variable is the natural logarithm of the sale price, as well as the main variable of interest Airbnb activity to better interpret the resulting relationship." Could you please clarify, how this is meant?
