OVERALL ASSESSMENT

Contribution

The topic of this master's thesis, i.e. transition to a cashless society and its impact on economic activity, is interesting and relevant to all economic subjects (households, firms, governments, and also to central banks). This dissertation is also an original piece of work, which contributes to the topic by forming an extensive outlook from a global perspective, examining factors such as business environment, globalization, and the shadow economy in relation to currency in circulation.

The thesis is divided into six chapters. After the introduction the author concentrates in the second chapter on the organization of the payment system, which includes a description of its evolution, the modern payment system and payment method trends, including electronic payment systems. The third chapter is oriented to the process of transition to a cashless society. Here the author describes a few of the stages of transformation in moving to a cashless society, barriers in shifting to it, and the adoption of the electronic payment system. The fourth chapter is oriented to the review of mainly academic literature associated with the field of transition to a cashless society. Subsequently the author formulates – on the basis of elaborating the literature review – three research hypotheses, i.e.:

- H1: Alternative methods of payment through indirect benefits leading to a healthier business environment;
- H2: The demand for cash being higher for countries with greater shadow economies;
- H3: The globalization and market integration being negatively affected if the share of currency circulated is large).

The fifth chapter is the main chapter of the thesis, including both data description and empirical analysis based on different panel data approaches.

Methods

The author applied different panel data approaches from a simple one (pooled OLS) to a more advanced one (GMM). The advisor of this thesis finds these methods appropriate for the aim of the master thesis.

Literature

The literature review is around standard level, i.e. well balanced, including both original sources of literature and current applied studies oriented to the transition to a "cashless society".
