Contribution

This is the first meta-analysis on the relation between beauty and productivity (both broadly defined), so the contribution is clear and after some revisions publishable in an international journal. The author collects 418 estimates of the beauty effect reported in 37 studies. Because individual studies use different measures of beauty and productivity (and, of course, not always estimate the relationship using a log-log specification), the estimates are not directly comparable and have to be translated to partial correlation coefficients. This is common practice, and the conversion is conducted competently. The author documents substantial publication bias in the literature: positive and statistically significant estimates of the beauty effect are preferentially selected for publication, which exaggerates the mean reported coefficient and also the prima facie conclusions one would from the literature. When corrected for publication bias, little evidence for any substantial beauty-productivity nexus remains in the literature. The author also discusses in detail how context in which the coefficients.

Methods

The author uses both classical meta-regression methods and also new techniques: for example, the stem-based technique due to Furukawa (2019, MIT WP). I also appreciate the use of modern methods to tackle model uncertainty inherent in meta-analysis: Bayesian model averaging and frequentist model averaging. In meta-regression techniques, it is important to take into account that the standard error can be endogenous to the reported estimate. A natural instrument is the number of observations used in the primary study, which is what the author uses. Excellent work.

Literature

No problems here, all relevant papers are properly cited.

Manuscript form

The thesis is written in solid English and typeset competently in LaTeX. Some information seems to be missing from Figure B.1. Figure C.1 is probably redundant. Figures D.1 and 4.2 are hard to read. But these are minor issues.
