Contribution

The topic of zombie firms is highly relevant in the post-crisis world. Martin tackles the topic successfully as he builds on well-established methods but uses a unique dataset from Slovakia, and he persuasively shows how zombie firms are negatively associated with productivity. His close cooperation with the National Bank of Slovakia proved to be fruitful as he delivers interesting results both for policymakers in Slovakia and the academic audience around the globe.

Methods

The methods are carefully chosen based on previous literature. Occasional changes are due to the specificity of the data. Although some models could be specified more articulately, Martin had to deal with only remote access to the data so the regressions could not be estimated at will. Having more time and the possibility to work on-site, I believe he would come up with even better and more robust results.

Literature

The literature review was reworked and hopefully rid itself of all problematic parts raised during the defense. Overall, the paper provides extensive and to the point literature review.

Manuscript form

The paper is very well written, and its structure is clear. The problematic parts where the suspicion of plagiarism was high were hopefully all taken care of. As it is, the manuscript meets the expected level of a bachelor's thesis.

Summary and suggested questions for the discussion during the defense

In summary, I believe it is a very good thesis deserving the highest grade. During the defense, I would like Martin to elaborate on the robustness of the results concerning the definition of zombie firms. Because he was not able to conduct certain robustness tests (data access issues), Martin could talk about how he would conduct those tests and what results he expects them to have and why. Also, possible extensions of this paper should be discussed as such discussion is not included in the paper. It would be worthwhile, for instance, to discuss sectoral heterogeneity of the impact of zombie firms on productivity. Lastly, Martin should convincingly explain the reasons why his thesis did not meet the standards of academic conduct during the first defense.
