**Průběh obhajoby:** The thesis defense starts at 15:05. The opening of the defense,

provided by the commission chair, was followed by a summary of the defendant's studies and publication record. Upon the summary, the defendant presented the main results, theoretical framework, and research design of the dissertation research. After the presentation, the reviewers summarized their reviews and compiled their feedback to the presentation. The observations included critique regarding the presentation of the conceptual framework, the unused potential of selected motives included in the dissertation. In this regard, a multifaceted approach to the subject matter might be overly broad. It was suggested that, at some points, the vast extent of the work hindered the depth of the analysis. Before the general discussion was allowed, the defendant reacted to the remarks brought forward by the reviewers. The defendant specifically addressed how particular subdisciplines connected to the research and used the theoretical distinction to clarify the problem of self-fulfilling prophecy versus the generative metaphor problem in the metaphor studies. Questions raised during the general debate concerned the kinds of future the technological metaphors draw, the lifetime of metaphors, the modalities of their use, the selection of time period, which was studied. The defendant sufficiently clarified the questions raised, and inter alia argued why the work centers on the performative action of the metaphors in the present, linked the notions drawn from the philosophy of creative evolution and project of modernity to the

study of technological metaphor.
