#### Contribution

Klára analyses the relation between life satisfaction, in particular happiness and sugar consumption. Given the worldwide criticism of GDP being the indicator as "human well being", hapiness could serve as an alternative way how to measure human well being. Therefore, identifying variables, which affect happiness is relevant topic for research. Klára's main contribution lies in explaining the effect of sugar consumption on happiness. She uses rich dataset from INHERIT project conducted by Zvěřinová et al. (2018). To answer the research question about relation of happiness and sugar consumption she employes logit and negative binomial model. She concludes that an association between sugar consumption and happines was not found in the dataset.

#### Methods

I highly appreciate Klara's methodology part. She deeply discusess various econometrics technique and give a clear reason for using logit and negative binomial model, and for determinants of life satisfaction and happiness the multinomial logit and bivariate probit model. On the other hand, in the conclusion part she explains advantages of Structural Equation Modeling (SEM) over chosen methods. I would appreciate more reasoning of preffering her chosen methods over SEM.

### Literature

The literature part is very well structured and provides a clear introduction to the topic. Klara provides a rich list of related literature for both measurment the life satisfaction and happines as well as for the methodology she used. However, I miss literature about behavioral economics insights and its help to reduce sugar consumption. The tax reduction is not the only attempt to reduce sugar consumption as is stated on page 2.

#### Manuscript form

The manuscript form suits the needs for Bachelor thesis. However, I would appreciate using advanced editing tools, for example LaTex.

#### Summary and suggested questions for the discussion during the defense

Overall, a student shows an excellent practical use of a theoretical knowledge earned during the bachelor studies. The thesis is well structured and a reader is able to understand the main message of the thesis from the beginning. For the discussion during the defense I would aim on the practical use of the results. Moreover, on page 28 she states "Consequently, there is an indication that people who consume more sugar tend to be less happy and less satisfied. Nonetheless, these results should be interpreted with caution, due to a potential bias." What are these potential bias?
