In her thesis, Tereza Hudcová focuses on the reward-based crowdfunding in the Czech Republic. The main (and from my perspective surprising) finding of the thesis is that the language style of project descriptions does not influence the success of the project. That conclusion is based on the analysis of all projects since the platform was launched in 2012. Nowadays, the video starts to dominate the Internet, and the thesis confirms that the inclusion of a video enhances the success of the project. Tereza worked on her thesis regularly, and all my critical remarks very incorporated in the draft.

Contribution

The original idea of the thesis is very interesting, and the results may be surprising. The thesis analyses the dataset as no other work in the Czech Republic. The influence of language style on crowdfunding success has been investigated before in other regions, but this thesis provides contradictor results. The thesis also provides a set of tools that can be further used in similar research. Further directions are nicely indicated at the end of chapter 6.

Methods

Tereza uses various quantitative methods in her thesis and combines them appropriately. Firstly the textual analysis is used to get variables for regression analysis. Then out of the pool of dozens of variables, the key ones are selected using Bayesian Model averaging, and lastly, logistic regression is used. These are proper techniques to investigate a dataset where the dependent variable is binary and also in a situation where there are quite a few possible explanatory variables.

Literature

The literature overview covers all key-studies that were written in the Czech Republic to show the added value of the thesis as well as similar research from abroad to support the key hypothesis, compare results and get further support in the used methods. The thesis is written using the standardized LaTeX template; hence the work with the literature is proper and original ideas are correctly referred to.

Manuscript form

The thesis is well structured and formatted. In the beginning, the thesis presents the motivation and the area of crowdfunding and language processing; then, it presents the methods and applies them. The language style is fine and quite readable, but one can always find a part that could be further improved.
