Petra Lancuchová focuses on the evolution of asset poverty in Slovakia in her thesis. The thesis concludes that favorable economic development in the last five years did not reduce the risk of asset poverty for everyone. Economic development seems to be favorable, especially for households with a higher value of assets, which may widen the gap between those who are wealthy and those who are poor.

The analysis uses data from the Slovak HFSC (Household Finance and Consumption Survey) from 2014 and information about macroeconomic development in Slovakia to simulate the dataset in 2019. Petra worked on her thesis very independently and with attention to detail. I am glad I had the draft of the thesis in time so that all my critical comments could be discussed and reflected in the thesis.

#### Contribution

Petra uses a simulation based on the observed data to get a dataset and analyze the change in asset poverty. This way, it is possible to bring a piece of new information on time without waiting for the next survey. Such an approach is valuable and brings new information in a timely manner. Once the next survey data are available, the prediction of this thesis could be verified.

### Methods

Firstly the simulation of the variables is performed. The simulation is simple but effective. For the quantitative analysis of the cross-sectional dataset OLS and quantile regression is used. Given the number of explanatory variables, it is a proper and standard technique. The thesis also provides information about the assumptions tested, hence it is possible to interpret the results correctly.

### Literature

A literature overview is sufficient for the analysis Petra has created. It covers both the asset poverty discussion as well as parts of economic development. The work with the literature follows the required standards. The only "missing" part is the information about what other similar HFSC surveys tell us about asset poverty. It would also be useful for further research as the approach in this thesis could be used in other countries as well.

### Manuscript form
