In her thesis, Radka Doležalová focuses on the used cars and their price determinants. To do that, she scrapped more than 50 thousand car offerings from the German online marketplace, and for each of the car coded almost 60 attributes. To analyze such a dataset, the Bayesian model averaging approach and hedonic price model is used. Radka worked on her thesis regularly, and all my remarks are already incorporated in the thesis.

I could see the overall progress of the thesis, and I know that the handling of the data was the most time-consuming part. We also discussed several possible approaches to some of the explanatory variables, as well as the way the results could be presented. Therefore I can only briefly comment on each part below that I think was done with the utmost care and dedication.

Contribution

The idea of the hedonic price model applied to a used car market is not new, but the dataset is brilliant. A similar analysis is scarce since it takes a lot of effort to compile such a dataset. The thesis confirms existing literature findings in some areas, but it also allows us to examine new possible price determinants.

Methods

Radka uses Bayesian Model averaging to tackle all collected data. It is a proper method to do so. It should also be stressed out, that Radka carefully went one variable by another to fully understand the data into detail. The results are commented nicely, so the reader is not lost in many explanatory variables.

Literature

The literature overview covers existing literature and also provided a summary of existing results, which are mostly verified by the empirical part.

Manuscript form

The thesis is well structured and formatted. Radka uses a standardized Latex template but also accompanies all figures and tables with comments.

Summary and suggested questions for the discussion during the defense

I have not further questions regarding the content of the thesis. For the defense, I would suggest that Radka elaborates on her expectations about the results that she had prior to the empirical investigation of the dataset.

The results of the Urkund analysis do not indicate significant text similarity with other available sources.
