Contribution

Maria started to work on the thesis more than year and a half ago and she has made substantial progress since that time in her mastery of econometrics. In her thesis she focuses on the nexus between migration flows and the level of development of the country of origin and provides the first meta-analysis on the topic. Writing the first meta-analysis is difficult because one has to design an entire structure of the dataset (See Table 4.5 for an example of the work involved) and requires the manual collection of thousands of data points from individual studies (40 in this case). Of course it is very difficult to establish causality in this literature, but Maria's results suggest that there is little correlation between development and migration. She also finds very little publication bias and documents the sources of heterogeneity in the literature. I believe the contribution is solid. It would require a lot of work, but a paper based on this thesis could be potentially be published in World Development. Thus I award 23 points.

Methods

Maria has mastered several modern meta-analysis techniques including the weighted average of adequately powered and Bayesian model averaging. She clusters standard errors at the study level and uses the number of observations as an instrument for the standard error. There are several recently developed techniques that are mentioned in the thesis but not applied (Andrews and Kasy, Furukawa, etc.). Thus I award 20 points.

Literature

As far as I can tell, almost all relevant papers are properly quoted. Thus I award 18 points.

Manuscript form

The thesis is typeset in LaTeX and written in competent English, which tends to be a bit wooden and unnecessarily complicated at times. But Maria has her entire research career in front of her and a lot of time to improve further. Thus I award 16 points.

Summary and suggested questions for the discussion during the defense

I recommend the thesis for defense with grade C or better depending on the committee's evaluation. Suggested question for thesis defense: could you comment on the outlier in the upper right corner of Figure 5.1? Isn't it a typo? The results of the Urkund analysis do not indicate significant text similarity with other available sources.
