Contribution

In her thesis, the author studies the relationship between migration and development. For that purpose, the author collects 179 estimates from 40 studies and conducts a meta-analysis. The results indicate presence of publication bias thus implying only a weak relationship between economic development and migration. As no meta-analysis was conducted on this topic yet, I believe that the author's analysis makes a nice contribution to the literature.

The author does a good job of describing her methodological approach and discussing the results of her meta-analysis and her findings. However, the results lack a clearer connection to the theoretical literature as their implications are not discussed in light of the theory covered in Chapter 2 of the thesis. Furthermore, in some instances it is not clear what relationship is being studied as the author mostly refers to the question at hand as the relationship between migration and development not specifying whether it is imigration/emigration/net migration.

Methods

In her thesis the author conducts a meta-analysis of studies assessing the relationship between economic development and migration. The first step of her analysis is a literature search to identify relevant studies. She than relies on Funnel Asymmetry Test and Precision Effect Test to test for the presence of publication bias in primary studies. The author also studies heterogeneity in the research by relying on Bayesian Model Averaging. The author seems to have a strong grasp of the methodology and its foundations as documented by an extensive chapter discussing the methodological approach (Chapter 3).

Literature

The author provides a comprehensive review of both the theoretical literature as well as empirical studies assessing the relationship between migration and development. All studies in the main text seem to be correctly referenced. However, not all studies in Table A.1, which contains the list of all primary studies used in the meta-analysis, are referenced. This is the case of e.g. Adams JR. & Page (2005), Belot & Ederveen (2012), Cappelen et al. (2015), Clark et al. (2002), Clark et al. (2004). Thus hindering the reader's ability to go through the primary studies.

Manuscript form

The thesis is written in proper english and nicely typesetted in Latex. All tables and figures are self-contained and overall the thesis reads well. Though the thesis contains some errors, these are sparse and do not hinder the understanding of the text.

Summary and suggested questions for the discussion during the defense

Overall I believe that the thesis deals with a relevant topic using appropriate methodological approach. The results of the Urkund analysis do not indicate significant text similarity with other available
