- Stages of RA pg. 14- 15 source is missing
- Chapter 2. 5 (pg. 17-21) source is missing
- There are a few shortcomings in stylistic level of the text: e.g. pg 10 IP is missing, MCP are there twice, pg. 79 in some sentences a dots after sentence are missing.
- Pg. 55 Long term therapy plan includes : Improve the DLA (daily life activities), commonly used abbreviation is ADL: Activities of daily living
- TrgPs and SMS abbreviations (pg. 58, 67) are missing in the list of Abbreviations
