

The aim of presented work was to contribute to the understanding of molecular mechanisms underlying pathogenesis of several polygenic disorders by

- 1) identifying (new) quantitative trait loci in polygenic disease(s) with up to now insufficiently explored genetic component contributing to disease etiology
- 2) testing the contribution of previously identified candidate genes to pathogenesis of diseases with known QTLs and finding new interactions and subtyping associations
