The rigorous thesis in this case is just a formal exercise without any value added. As far as I understand, the rigorous thesis examination has just Pass and Fail grade options. Therefore I suggest the pass grade - the work done by Andrea deserves the passing grade. But I strongly feel that the whole system, when the student presents a rigorous thesis instead of transforming parts of good diploma thesis into IES WP and subsequently into an article submitted to decent journal, is a bad system.
