# THESIS TOPIC: HONOR KILLING OF PALESTINIAN WOMEN - A CRITICAL ANALYSIS

## **INTRODUCTION:**

In my research, I'll be studying the reasons and motives that lead to honor killings in Palestine. ### Methodology - Discourse Analysis:

The initial section of the research methodology would consist of going through the relevant literature to violent acts against women in Palestinian communities. From this point onwards, the work shall go into analyzing the press coverage of violence against

women; whether it even exists to begin with, and if so, then how these violent acts are being framed by the news media. Because depending on how the media networks are biased, they might either exaggerate minor transgressions into a huge matter, or possibly the other way where they might omit certain events which might bias the general news reader against the supposed victim in question. Or as mentioned already, the press might choose to skip reporting the incident entirely, in order to pretend there are no issues whatsoever.

The next part of my research would rely on setting up interviews with some of the people in the affected communities. Also, seeing as how some of the successful female business owners or leaders are viewed in a negative light, it would do good to interview such women for a better understanding of the situation on the ground. If things work out well, I would be able to land some interviews with someone in the Ministry of Women's Affairs, possibly even the minister herself.

#### Conclusion:

Preliminary reading would suggest that honor killings may be a byproduct of how the Palestinian society has been structured, over the last few decades especially. At a cursory glance, one can already sense that libertarianism isn't a cornerstone of Palestinian society. However, more work needs to be done to verify if the findings support my initial guesswork regarding the motives, or if there is an entirely unrelated reason as to why these acts occur. You never know until you *really* know, after all.
