

The goal of the thesis is to explain the portfolio diversification with graph theory. It introduces needed terminology from financial mathematics and from graph theory. The described methods is used on real data and are compared with classic method where risk is measured by the standard deviation and mean absolute deviation and used criteria are based on the Markowitz approach and Sharpe ratio. The software Mathematica is used for computation and graph rendering.
