Short summary

The thesis copes with the recent COVID-19 crisis. In particular, the author investigates the impact of different fiscal measures aiming to contain the crisis on non-performing loan (NPL) developments. Despite, the unprecedented drop in economic activities for European economies, contrary to the crisis in 2007, it was not associated with any substantial increase in NPLs. In this respect, the thesis try to analyse the impact of extensive fiscal measures on this new phenomena.

Contribution

The thesis brings a unique analysis based on the data covering the pandemic period. In this respect, the EBA Risk Dashboard data on NPL ratios and the ESRB database providing information on fiscal measures with the break down by country and economic sectors (NACE) were instrumental for the study. The thesis clearly contributes to better understand how different fiscal measures affect NPL ratios. This has clear policy implications and could also help in estimation of credit risk models using data covering also the pandemic period. Without taking those effects into account, the estimated credit risk models might underestimate credit risk in the future.

Methods

First, the author use static panel model with both fixed and random effects. Second, the dynamic panel model using Arellano and Bond estimates are employed. The author use R to proceed with all estimates. The methods and approaches used in the paper reflect the current practices used in similar cases.

Literature

The thesis well covers all relevant literature including the latest papers dealing with the topics of NPLs. Author made very extensive investigation on the available literature well justifying his approaches used in the thesis.

Manuscript form

The paper is well written using latex. Overall, it resembles a diploma thesis rather than bachelor. It is also well structured and providing all information needed to make the final conclusions.

Overall evaluation and suggested questions for the discussion during the defense

The thesis deals with widely discussed, but so far unexplored topic. It is well written and connected to the relevant literature with interesting conclusions that could inform the ongoing discussions of researchers and policy makers alike. In my view, the thesis fulfils the requirements for a bachelor thesis at IES, Faculty of Social Sciences, Charles University, I highly recommend it for the defense and suggest a grade A. The thesis could be also considered to be awarded as an extraordinarily good bachelor thesis with some potential for a future publication. The results of the Urkund analysis do not indicate significant text similarity with other available sources. As the thesis is well written addressing all possible questions, I would suggest that the author could talk about potential further research during his defense.
