Short summary

The thesis provides a complex analysis of the potential determinants of Czech banks' profitability (in terms of ROA and ROE). During the last ten years the Czech commercial banks were (and still are, even in the 2021 COVID year) very profitable (and hence represent a substantial source of profit for their parent institutions). However, they still keep a very solid liquidity position under relatively low or adequate risks (especially credit risk). These aspects may seem in mutual contradiction (low risk (high capital ratio) - high liquidity - high profitability), but still Czech banking sector (and actually all major banks) have managed to achieve this over a long term horizon. It is therefore clear the drivers of such a state are important to analyze and may contribute to discussion on the determinants of Czech banks' performance.

The analysis comprises an extensive set of data. Daniel put a lot of effort in collecting data, i.a. from obligatory information published regularly on websites of individual banks (according to 163/2014 Coll.) and managed to deal with numerous inconsistencies.

He also introduced and discussed a wide range of potential determinants, both bank-specific and macroeconomic. The thesis should be praised for extensive discussion on results, interpretation from various perspectives and further research proposals.

Daniel was very devoted to the topic and worked on the thesis with enthusiasm and interest.

Contribution

Bank profitability is an obvious topic of interest for every single bank and e.g. supervisors all over the world, so the thesis does not analyze an issue that would not be familiar to researchers and bank professionals. Also, the results did not reveal any surprising information or relationships.

The unique contribution of this thesis is its extensive data collection effort and wide scope of variables analyzed with the special focus on the Czech Republic.

Methods – The methods used were adequate to the analysis performed. Daniel made use of extensive econometric analysis which was appropriate to the topic, he used a set of bank-specific and macroeconomic variables which were tested for profitability determination effects by a general profitability model (using GMM, FE, and OLS methods). He also consulted the econometric part with Mr. Barunik, which proved his frank interest in the relevance and correctness of the econometric methodology applied.

Literature – I did not identify any shortcomings in Daniel's work with literature, the literature used was relevant and up-to-date.

Manuscript form – I did not find any shortcomings in the manuscript form, the thesis is logically structured, easy to follow, clear in hypotheses tested, results and their interpretation. Only the graphical part of 5. Results may not be well arranged for every reader.

The level of (English) language and formulation skills are high.

The results of the Urkund analysis do not indicate significant text similarity with other available sources, all other similarities are well sourced.
