Short summary

In her thesis, Anna Bezuchová estimated the feedback effects between non-performing loans and the macroeconomic and other bank-related variables. She utilized the framework of panel VAR models, and instead of relying on aggregated financial data, she used bank-level data. Her findings are sometimes quite interesting; in particular, a rise in non-performing loans decreases the unemployment rate. Besides, she documents cross-country differences and confirms the fragmentation of financial markets in the EU.

Contribution

The main contribution is twofold. Anna employs bank-level data, has the most up-to-date dataset, and focuses on medium-term effects on business cycle frequencies, while the previous papers investigated short-run responses over several quarters. Besides, Anna reports both generalized

impulse response functions and local projections so that she tests the

sensitivity of the results on the method.

Methods

Anna's thesis relies on panel VAR with generalized impulse responses and on local projections. In particular, the estimation of panel VAR models is demanding, but Anna describes the methodology nicely, mentions the estimation issues, and reports relevant test statistics. So technically, the method seems well implemented. The same holds for the local projections. A full model combining both macro and financial variables was chosen as a baseline, which, however, leads to impulse responses with wide confidence intervals. The confidence intervals of local projections are markedly lower, so some interpretation of the dynamic responses is possible.

Literature

The work with the literature is on par with the standards in the profession.

Manuscript form

The thesis is well structured and follows the conventions. Still, it is one of those theses where there's a lot of work behind, and the text itself could have been much shorter and could work better than it does right now.

The results of the Urkund analysis do not indicate significant text similarity with other available sources.

Suggested questions:

- If Anna had started with her thesis again, would she prefer panel VAR or local projections? Why?
- Is there any intuition why the unemployment rate is supposed to decrease with increased non-performing loans?

Overall, I suggest Anna Bezuchova's thesis for defense, and I recommend grade A.
