Short summary

The author aims to examine the market for passenger cars in the Slovakia. More specifically thesis examines the effect of registration fees on the number of passenger cars entering the national vehicle evidence and how the change in fuel price affects the decision of buying car.

Contribution

The student generally demonstrates the ability to critical thinking and the ability to draw conclusions based on the knowledge of relevant theory and empirics.

Methods

- 1) Author states that he grouped the cars for several categories using some of their characteristics according to some threshold values. I have not found any explanation of the methodology (maybe I have missed it) on how these threshold values were determined. What logic the author was applying when grouping the cars? Are the chosen thresholds for grouping justified? If yes, are there any sources that the reader can be refereed to? The methods of threshold selection are very important as different thresholds may lead to very different results.
- 2) The textbook description of OLS methodology on page 27 is redundant. There is no need to derive OLS estimator in the paper.
- 3) As far as I understood the author tries to differentiate between the new and second-hand cars by introducing dummies and interaction terms in his empirical specification. However, as the author notes himself (maybe indirectly) the new car markets and the used car markets maybe structurally different. In other words, these cars may be treated as different goods, and thus including them in one empirical specification (one equation) may possibly create some problems. As a robustness check it would be nice to estimate the equations of interest for new and second-hand cars separately.

Literature

The author demonstrates a full understanding of the literature on the car and fuel market in EU member states. But a number of the quoted literature is not relevant, in my opinion, to the research topic of the thesis.

However, I would like to suggest to ask the author regarding the points I outlined in the methodogy section during the defense.
