#### **OVERALL ASSESSMENT:**

#### **Short summary**

The thesis is quite early to what will surely become a large field of study, namely the economic, social and political impacts of the COVID-19 pandemic. The question of how the spread of the virus impacted election results is of high interest not only in Czechia, and the author uses appropriate range of tools for a bachelor's thesis to test the hypthesis that nuber of infected individuals and deaths affected the election results.

#### Contribution

Given the limited amount of research that has been produced on the pandemic due to its being a very recent event, the thesis should be viewed as pioneering work in a field where little literature exists. This is also the main contribution of the thesis – especially given its local focus, the thesis seeks to answer previously relatively unexamined questions. The work also acknowledges that there is limited data, as there has been limited number of elections since the pandemic (and typically at most one per country).

#### **Methods**

The author pays appropriate attention to pre-analyzing the data for multicollinearity and other potential issues with the dataset. Some variables, such as ,Believers' would benefit from more precise defnition and reasoning for their inclusion, although their meaning is implied. The author gives sufficient exposure to the methods used and their properties and required assumptions.

Less precision is involved whne discussing various panel data methods. It would be better to avoid vague statements such as ,*The fixed effects estimation has a few more assumptions that are somehow of an extended version of the assumptions for the OLS estimator.*'

Appropriate methods are used to test the assumptions of various methods and to choose between the describe **methods**.

In some sections, the author in their discussion describes the possible effect of various age groups in dependence on the pandemics proliferation. It might be interesting therefore to include interactions of COVID cases and age variables in the model.

It might furthermore be worth to think a bit more about the data involved. Given the very high R-squared values, it might be worth rethinking whether casual relationship is actually being captured. For instance, both voter turnout and COVID cases could be correlated with existing (or previous) pandemic measures, which are not included in the models.

#### Literature

While the author acknowledges that literature is limited for the ongoing COVID-19 pandemic and gives well-supported reasons for inclusion of most control variables, it might have been worthwhile looking also at existing literature of other *vis major* forces influencing elections and the methods and

procedures used in those cases. While the claims in the work are generally well referenced, the citation style is somewhat inconsistent.

#### Manuscript form

The manuscript is logically structured and properly referenced.

A few notes I would make is to be more careful about proper capitalization of headings and subheadings in English. It's also better for consistency's sake to use either plural or singular form when refering to the author throughout the entire work. In some sections, the work would benefit for more proofreading.

#### Overall evaluation and suggested questions for the discussion during the defense

The thesis fulfills the requirements for a bachelor thesis at the Institute of Economic Studies, and I therefore recommend it for the defense and suggest a grade B.

For the defense, I would suggest more discussion on the following issues:

- Could it be possible that another non-measure variable could be a determining factor both for current COVID cases and voter turnout (and support for government parties), such as pandemic measures imposed in the current od past periods? Speaking of which, it might be of interest to introduce lagged variables, as the impact of measures (or deaths or cases) on preferences might not be immediate.
- It might be worth considering testing for joint significance of pandemic-related variables rather than individual one.
- More literature exists on the 2020 US election. While this is briefly mentioned in the Literature Review, more comparative analysis of the impact of the pandemic in the US and Czechia would be benefitial, as well as more specific examination of whether the pandemic harmed specifically ruling parties, or parties / candidates with similar political leaning.
