OVERALL ASSESSMENT (provided in English, Czech, or Slovak):

Short summary

The bachelor thesis by Zuzana Meteláková aims at analyzing regional determinants (or correlates) of the inbalance between the supply of and demand for places in kindergartens in the Czech Republic. Zuzana first presents the system of pre-primary education in the Czech Republic with all its specificities. Next, she reviews the Czech literature on the topic as well as several international studies within the same scope. Finally, she moves to empirical analysis, which is performed on district-level (okresy) data from the last three pre-pandemic school years. Applying relevant panel-data estimation techinques Zuzana finds that the share of rejected kindergarten applications is the highest in districst with the highest wages and highest net migration.

Contribution

While the topic of kindergarten availability is often discussed in the media, there are very few rigorous empirical analyses of this issue. This makes the contribution of Zuzana's work clear: she neatly summarizes factors that correlate with the number of rejected kindergarten applications, what might help parents decide about their residence or kindergarted application strategy and, most importantly, might help policymakers predict the demand for places in kindergartens.

Methods

Zuzana hse collected data from 76 Czech districts (okresy) for three consecutive pre-pandemic school years. Consequently, she works with panel data and applies panel data methods. Presentation of panel estimation techniques is written in a textbook-style. The most important thing is that Zuzana applies these methids correctly and with understanding. She was very careful about checking the conditions behind each approach and choosing the most reliable method. I also appreciate careful discussion of the timing of the included explanatory variables.

Interpretation of regression estimates is a bit clumsy and a reader might find it difficult to get the main message of the thesis, to figure out what is the main result. Nevertheless, I appreciate the attempt to quantify the estimated coeficients in a meaningful way.

Literature

The literature review is very nice. Zuzane picked the relevant Czech papers and organized their description in an intuitive way: not paper y paper, but topic by topic. It is obvious that she read all there papers and understood them.

Manuscript form

The manuscript is well-organized and written in a good English. Sometimes sentences are a bit too long and literate rather than scientific language is used. But overall, the thesi reads well and makes a confident impression. Figures, tables and maps are well presented and are self-explanatory.

The thesis by Zuzana Meteláková definitely fulfills the requirements for a bachelor thesis at IES, Faculty of Social Sciences, Charles University, I recommend it for the defense and suggest a grade A. This is because Zuzana put a lot of effort into this work, an effort that resulted in a comprehensive, carefully performed and neatly presented thesis. I appreciate the attention that Zuzana pays to details, her willingness to understand everything she works on, and precision with which she does the work. Although sometimes this is on the cost of text clarity and compactness.

There is little discussion about causality in the thesis and I suggest that Zuzana talks more about it during the defence. Specifically, can it be concluded that higher district-level wages *cause* a higher rejection rate of kindergarten applications?

The results of the Urkund analysis do not indicate significant text similarity with other available sources.
