Reviewer 1

This thesis sets out to give a comprehensive overview of nativism and a concept and argues cogently for the importance of such a concept. It clearly distinguishes between nativism and populism, the distinction between or even relationship between nativism and nationalism is slightly less clearly drawn, though the key appears to be the commitment to a core cultural community that cannot be entirely reduced to commitment to institutions i.e. you can have a civic nationalism but not a civic nativism. The study gives an excellent overview of the state of the art of the literature on nativism and links this to some of the most important debates in both contemporary academia and society. Perhaps though (following Brubaker) we shouldn't be asking what nativism is but rather what it does!

Reviewer 2

This is an impressive effort to disentangle the concept of nativism. The dissertation provides a comprehensive conceptual analysis of nativism phenomenon. Comparisons of nativism concept with other overlapping concepts such as populism were very useful. The student has offered a praise-worthy and meticulously detailed deconstruction of the nativism term, which is very time-relevant, as this concept begins to appear quite frequently in the context of security debates or as part of security issues. I believe that efforts to analyse nativism beyond Western European and North American contexts are also a welcome addition to an already comprehensive analysis conducted in this dissertation.
