But more standard way how to estimate the divorce rates would be to start with the beginning of the union. I think in your data you could actually use this more standard estimation.

I was a bit surprised when you mentioned that literature claims that women's control is linked to the lowest level of matter deprivation. I think that literature claims that if you give benefits to pro-households than it would be better to give them to a woman, as she will use them on children.
