The Defense Committee Chair initiated the defense by verbal statements confirming (i) that a satisfactory number of Defense Committee Members were present, (ii) that the student fulfilled all the requirements as listed in the Study and Examination Code of

The Defense Committee Chair introduced all committee members and asked Dominika Ehrenbergerová to present her dissertation thesis. Dominika Ehrenbergerová shortly described the main findings of the dissertation. Afterwards, Dominika Ehrenbergerová focused on the third chapter called "When Does Monetary Policy Sway House Prices? A Meta-Analysis" in more detail.

After reading the referees' (appointed by the Graduation Council) comments, an open discussion followed. During the discussion, Dominika Ehrenbergerová satisfactorily answered all the questions from the audience.

During the Defense Committee voting, Dominika Ehrenbergerová and the audience left the room, and then committee members voted.

Question: There are generally two main factors having an effect on the prices - wars and infrastructure. Could you try to control and correct for these changes in your work?

Answer: Within our work, we do not have direct control for infrastructure as they are usually country specific. We control for supply factors which are a link to house prices. For example, as a control for demand we use tourism in a country which could also be

Question: Why do you consider the final results/estimates values still too low?

Answer: This may be subjective, and it is difficult to say where the threshold is. We do lean on relevant literature studying this. The committee members were satisfied with the answer.

Question: What do you think about the effect of macroprudential policies?

Answer: I think that because the effect is not that strong, macroprudential policies are needed when house prices are high. I am not aware of any literature on this topic and it is a good topic for future research.
