

This thesis deals with stochastic programming problems with probabilistic constraints with discrete distribution. Finiteness and correctness of algorithm for finding  $p$ -level efficient points is proved and I implement this algorithm in R. I relax the feasible set to get convex problem and I study properties of the relaxed set. Results for linear, integer and nonlinear problems are presented. In an example I compare discrete approach with the continuous one.
