COMMENTARY:

The author has decided to analyze identity issue in post-Dayton Bosnia and Herzegovina still being split along the ethnic cleavage. Mrs. Acimovac has chosen undoubtedly relevant but difficult topic.

The thesis consists of 4 chapters (excluding introduction and conclusion): theoretical framework, BiH as Yugoslavia en miniature and post-Dayton BiH, Analysis of media discourse of the central news programs of two public broadcasters in January 2012, Hatred of the closest and death of multiculturalism.

She submitted the thesis which does not meat all formal criteria required by Faculty of Social

Science. It has 90 550 characters or 50 pages which is barely over the minimum limit. Although the

author declares as the main goal of her case study based thesis to prove discrimination within three

ethnic groups in Bosnia, through the public television programs (using critical discourse analysis),

hypothesis is missing. There also some other problems of formal character like grammar mistakes,

misspellings etc.. The author also refers to chapter X (page 29) which is not in the table of contents.

List of abbreviations includes shortcuts like WWII or EU which seems to be redundant for MA thesis

level.

Mrs. Acimovac definitely analyzed huge amount of sources and showed her ability to apply them, but

on the other side I find more than striking that the text of Dayton Peace Agreement or website of

Office of High Representative (and its decisions, findings, etc.) is missing in the list of sources.

To sum up this review the author failed in her attempt to apply various theories and concept related to

politics of identity to case study of BiH. The author also offers short excursion into history of BiH

which is to flat and descriptive to have some positive effect on the whole thesis

Some of conclusions and statements which occur throughout the whole thesis like Ethnic identity is

dominant in the BiH society and as such is problematic, Politics and ethnicity is a every day topic in

BiH are moreless trivial. I do lack deep analysis of empirical data which could verify of falsify

statements like Continuing, every election, after DPA, embraced power of ethnic identity: majority of

voters made their choices based on ethnical basis (p.37). Graphs or charts would be more than useful for

this reason.

Overall I do grade thesis 4 (failed).
