## **OVERALL ASSESSMENT** (provided in English, Czech, or Slovak):

The relationship and interactions between developed and developing countries are coming more and more under the scrutiny of economists. In her thesis, Veronika has decided to focus on the analysis of the approach of one now developed country, Slovakia, to developing countries. She has not only discussed the Slovak development assistance, but also quantitatively evaluated the approach of Slovak Republic to developing countries more generally using a policy index. For the first time ever, Veronika has created the Commitment to Development Index by the Centre for Global Development for Slovakia, which currently assesses 22 OECD DAC member countries on their overall approach to developing countries. It is published annually by the Center for Global Development, but until now Slovakia (similarly to the Czech Republic) has been not included, which, I hope, might change as a consequence of this paper on a regular basis.

Veronika has in detail analysed a number of data sources and results for Slovakia in international comparison and across many dimensions. The author analyses in detail why Slovakia scores well in environment and trade component and the main contribution of the thesis is in the sections 4.10 and 4.11.

As far as I know, the analysis in this thesis is the most complex empirical assessment of the Slovak development policy that I know of and this very good piece of work could serve as a basis for evaluation and monitoring of the Slovak development policy.

Although especially the empirical and policy contribution of this thesis is indisputable, a number of aspects of this thesis might be improved. While I provide some insufficiencies and suggestions for improvement below, it is important to keep in mind that this is a bachelor/undergraduate thesis and some of the issues would be more relevant if it was a master/graduate thesis or an academic paper.

- Despite generally being open-minded about developing countries, she has not avoided some oversymplifying and possibly harmful stereotypes about developing countries, for example in the introduction.
- The selection and width of literature reviewed provides a lot of space for improvement. Veronika does provide the overview of some literature, but in both general and Slovak-related literature, it is insufficient.
- The flow of the text, its structure and its argument does not feel natural and would deserve better thinking and a few rewrittings.
- Some of the parts of the thesis are mostly descriptive (most of section 2 and parts of sections 3 and 4), not very analytic and would deserve to be better linked with the rest of the paper and the main contribution of the thesis.
- The purpose and relevance of section 2 should be better explained or it should be shortened and better incorporated into the thesis.
- Taking into account the number of data Veronika did crunch into creating the CDI for Slovakia and how she presented them in the Appendix, she should make even better use of them and comment on them more intensively.

Despite these critical comments, I believe this piece of economic analysis has its place in an academic or policy journal and would recommend Veronika to consider its publication. After incorporating the comments of the discussant and above, rewriting it and focusing on the parts with the most contribution (section 3 and especially 4.10 and 4.11), it could transform into a very interesting article with a clear contribution.

Suggested question for the defense is:

- "On the basis of your empirical analysis of Slovak development policy, what would be your recommendations for its improvement?"
- "How does your thesis relate with the literature on policy coherence for development?"
