## Constructive comments, explaining strengths and weaknesses (<u>at least 300</u> words):

The thesis is a study of the state-Islam relations in Putin's Russia. It aims to examine the key identity discourses on Russian Islam used by the Kremlin and three major Muslim organizations, namely the Russian Council of Mufties, the Central Spiritual Board of the Muslims of Russia, and the Coordination Center of Muslims in the North Caucasus. It draws on Poststructuralist Discourse Theory as theoretical framework.

Generally speaking, the thesis is an original piece of work that builds upon a good amount of literature and sources including - which is highly commendable - those of local origin. It shows both a robust theoretical underpinning and a sound knowledge of the subject matter, e.g. contemporary Russia; moreover, it is truly well written. Hence, my main criticism pertaining to the thesis points not to the manner the work is written, but rather to the limits and weaknesses of the chosen theoretical school as such, namely its heavy, if not excessive, reliance on analyzing and interpretation of texts including official statements and speeches, an approach which - while useful when exploring the processes of identity building - largely fails to grasp other various and no less important strategies of power employed by the key actors in question. For this reason, for the thesis defense I would suggest to shift the discussion away from discourse theories and their application on today's Russia and have the author speak of practical policies of the Kremlin and its sponsored religious organizations towards Islam.

## Specific questions you would like addressing at the oral defence (<u>at least 3</u> <u>questions</u>):

Please comment on the cadre policies of Putin's government towards Muslim organizations in Russia. For instance, how do you assess the penetration of Muslim clergy by FSB and other security services?

To my knowledge, two of the three Muslim organizations in question are largely Tatar. In your view, how does Moscow's policy towards these organization fit into reshaping the center-periphery relations under Putin and his overall centralization efforts vis-a-vis potentially troubled regions like Tatarstan?

Please discuss the role of external powers in the revival of Islam (both "official" and "unofficial") in Russia after 1991.
