**OVERALL ASSESSMENT** (provided in English, Czech, or Slovak):

Daniel Sentivany focues in his thesis on one of the most discussed economic policy of today: sovereign debt. Daniel analyses the forecasts of public debt in the Czech Republic. His main contribution is in empirically examining the sustainability of the public debt, including the estimation of so called fiscal gap in a systematic way.

The manuscript is very neatly written and many aspects from which the earlier versions of the thesis suffered have been significantly improved during the work on the thesis (including the toning down of the rather alarmist conclusions, lower number of direct quotations in the text, better specification of interpretation), although some other areas still show a potential for improvement such as the clarity of the presentation of the results.

Many of the results are interesting – for example, that the forecasted level of the debt in the year 2060, estimated using data from the year 2012, is 263.7% of GDP – but the thesis is also innovative in the way it compares the results according to different years of data. In terms of immediate policy contribution, I consider this thesis to be one of the more relevant bachelor theses that I have supervised.

Daniel Sentivany did an excellent job of writing a thesis. Therefore I recommend an overall grade of **excellent (výborně, 1)**. Furthermore, in my opinion, his thesis not only deserves the best grade, but also **the Dean's distinction**, for which I recommend it.
