OVERALL ASSESSMENT (provided in English, Czech, or Slovak):

The thesis is well written and well structured (perhaps apart from slightly non-stremlined passages in the introduction). Author's work with literature is extensive and up-to-date, all quotations seem to be properly addresed.

From the content point of view, the study is an original well elaborated piece of research which not only aplies recent research methods on Czech data but alos adds own contribution in form of augmentation of used models in order to provide beter explanatory power. The econometric part of the study is well above expectations of bachelor level, addressing properly most of the conditions and restrictions that used models are subject of. Perhaps the heteroskedasticity issue could have been more than just admitted.

As the estimates for diesel turned out to be less statistically robust than for petrol, I would perhaps encourage the author to search for the reasons of that more actively. Just a proposition which came to my ming - As demand for diesel is definitely driven by trucks and distant-transport in general, it would be legitimate to view Czech republic also as a transition country for land transport. In such a case, it might be interesting to point-out such points in time, when the price of diesel in the Czech Rapublic was most/least favourable out of all neighbouring countries and see if it does have an impact on where the transporters decide to fill their trucks on trans-european routes.

The only issue I did not understand in the thesis is why number of new registered cats was used as a proxy for income despite the fact, that monthly figures for various measurements of income are widely available. This is also mentioned in the conclusion but without any explanation of the reasons.

To summarize my oppinion, despite above mentioned comments, Jozef's thesis is highly above standard expected for a bachelor's thesis even at our faculty. In case of a successfull defence, I recommend it to be graded as "excellent" ("výborně", 1) and I do think that it would be worth considering an award in form of a Dean's distinction.

Below, I've listed some minor comments and typos, I've found, which might help with further publication of the research, which I strongly recommend.

P3. Best known study – a little too subjective formulation for academic research

P8 To return cross-border shopping for fuel – preposition "to" seems to be missing

P8 fuel is a product that is the same at any filling station – this is a rather strong statement, filling stations do as much as they could to differentiate their product and services.

P8 researchers mentioned in previous chapter concludes -the last "s" is redundant

P10 it do not depend on its price - "does"

P10 the consumer, the taxpayer - missing articles

P10 that there is possible for countries - "there" should be replaced by "it"

P13 negative price elasticity - it would be more precise to speak of own-price elasticity

P13 We have an explanatory - missing article

p15 is a slightly expanded demand function

P20 total taxation was 19.14 - CZK missing

P24 holing (holding, but I'd rather use "keeping")

The number of digits displayed in the tables could be lower for sake of lucidity
