## **OVERALL ASSESSMENT** (provided in English, Czech, or Slovak):

The thesis investigates an important and in particular policy relevant issue of inflation targeting implementation in a big and significant emerging market. The work is well structured. Literature review proves the understanding of both the literature concerning inflation targeting as well as literature focused on the developments in Russia. Moreover, the interpretation of the results indicates very good knowledge of the current situation in Russia.

The empirical work is carefully done. Relevant methods are implemented to test the main hypothesis. However, the potential problems and limitations of the empirical part are also acknowledged. Therefore it would be interesting to see some robustness checks by e.g. including the alternative variables in the model, especially concerning the interest rate proxy.

In the introduction it is mentioned that the results are applied in the forecasting the future developments in the Russian monetary policy but this does not seem to be the case at the end of the work. It would be good to provide more ideas on this at least in the conclusion.

In general writing can be improved at some points (e.g.providing background from previous literature in the section discussing the factors influencing inflation; or interpreting the results of the empirical part in a more concise way).

Suggested question for the defense: do you think that the crisis that hit Russia in mid 2008 could have influenced your results and if so in which way and what is the economic intuition for it?

Overall, the work is very well done and in the case of successful defense, I recommend "výborně" (1, excellent)
