In terms of the content diploma thesis achieved its aim. From a formal and language point of view it needs greater care when drafting of. It is written

somewhere in difficult English and with errors e.g.

• It is not used plural in sentence "edema caused by taking steroids or estrogen p.23",

• in Contents "adverse reaction" may be better termed a "Adverse effects" or "Side effect";

• incorrect breakdowns of content for atherosclerosis (paragraphs 14 to 17 should be placed under paragraph 13)

- "all medicines as doctor prescribesnes";
- Figure 1 is not figure but table (p.13)
- missing List of Figures

• Some sentences are also written in the second person e.g. "No matter if you're taking too much salt and your blood pressure is in normal stage because the coronary heart disease does not start when you have high blood pressure." (it should be in the third person in the passive)

- errors in references
- o incompleteness in the citation (eg. Faselis C et al, 2011)
- o missing the place of publisher (eg. MacGregor, G. & Kaplan, N.M., 2006)
- o inconsistent form of citation (eg. Sowers, J. R., Standley, P. R., Ram, J. L, Jacober,

S., Simpson, L. and Rose, K. (1993) Hyperinsulinemia, Insulin Resistance, and Hyperglycemia: Contributing Factors in the Pathogenesis of Hypertension and Atherosclerosis. The journal of clinical pharmacology 32(6):529-535.) Questions:

1. Does always increased salt intake cause of the hypertension? It depends on what?

2. How can you explain overweight as cause for hypertension?

3. You described risk factors for hypertension e.g. alcohol. How affects a moderate intake of red wine?
