## **OVERALL ASSESSMENT** (provided in English, Czech, or Slovak):

The thesis examines quantitatively an important policy topic, namely, whether the periods of too low interest rates can contribute to formation of asset price bubbles. It estimates various panel data models to examine the aforementioned policy issue. It uses the deviations from Taylor rule as the measure of monetary policy stance and defines the asset price bubbles in line with a recent study of Bordo and Lane (2013). Housing prices and stock market prices are used as asset prices.

In fact, the work of Bordo and Lane (2013) is closely related to this thesis and this thesis extends this work in several ways. I appreciate that the thesis at our institute can extend the recent study by a leading scholar in monetary history (Bordo).

The thesis is well-written. The author shows excellent understanding of related literature. The econometrics is applied consistently and uses the methods that are currently applied in the field. The thesis has a logical structure and clear hypotheses.

Overall, I suggest the thesis to be defended and recommend the grade A.
