He also proved his understanding of the topic. However, the thesis has got just one shortcomings, which is described in the following paragraph.

The thesis' is devided into 5 chapters, which are very straightforward and clear, but they seem too short sometimes. Despite the fact that this thesis is considered as empirical, I would appreciate, if author would included a discussion part on the problematics of the unemployment and also added his opinion.

Based on the findings, this thesis fulfills all requirements and therefore I recommend it for the defense with the grade **excellent**.
