### **OVERALL ASSESSMENT** (provided in English, Czech, or Slovak):

The thesis focuses on the estimation of interest rate pass-through in the euro area applying various cointegration methods. It examines the nature of transmission of short-term money market rates into the bank interest rates. It is very comphrensive study employing a wide range of econometric methods to a rich dataset.

One of the pertinent issues in this literature is to examine whether and to what extent the current global financial crisis changed the functioning of interest rate pass-through in the European countries. The thesis finds that indeed some change has taken place especially with the spreads increasing during the crisis and that the response of bank interest rates in various European countries became more heterogeneous during the crisis. Clearly, the changes in the interest rate pass-through have a direct policy relevance for the European Central Bank, as one of the steps for conducting successful monetary policy is a good knowledge of the transmission mechanism, i.e. how central bank actions affect the economy.

I could write a lenghty report on this thesis emphasizing its value added from different angles. But let me stress up front that this is one of the best Bachelor thesis that I read during approximately the last ten years. It is extremely comprehensive study with all appropriate literature cited. The relevant econometric methods and tests have been carried out to robustly examine the stability of the results. The thesis is extremely well written, very clear in the arguments and the text is polished and reads well. In addition, I was impressed that Jakub was able to master all advanced economtric methods by himself through self-study. This shows his intellectual maturity and ability to work independently on a large scale project.

I fully recommend the grade "výborně" (A, excellent).
