## OVERALL ASSESSMENT (provided in English, Czech, or Slovak):

The bachelor thesis of Jakub Kouřilek is devoted to energy economics, namely to the biofuels. Author focuses on the connection among biodiesel, diesel, rapeseed, soybeans, crude oil and natural gas. The theory overview includes biofuels as such, relevant EU legislation and touches also relating issues like food prices. With the use of (master level) econometrics (e.g. Prais-Winsten procedure) the analysis of price links/transformation among the biofuels is performed and their development in time is also described. The analysis brings some unexpected results, but their discussion is sufficient.

The student possess a very good knowledge of econometrics. I find the thesis to be very good and interesting. However, it is a bit difficult to follow, as the text does not flow, and also the results could have been presented in better way, especially structure of the analytical part is slightly confusing. There are several typos, see e.g. the last line of the Czech written abstract or conclusion (their instead of they).

Anyway, the author has certainly devoted significant amount of time to the field of biofuels and econometric literature and **I do recommend this thesis to be defended**, suggested grade is **excellent**.
