## **OVERALL ASSESSMENT** (provided in English, Czech, or Slovak):

This thesis contributes to the existing literature of growth econometrics with analysis of cultural dimensions on growth. The methodology relies on Bayesian model averaging corrected for endogenous regressors and thus quite a wide set of variables can be considered although the number of countries with all available data is rather limited.

From my point of view, the thesis written by Michal Frydrych is carefully conducted and I did not find any substantial methodological flaws and the methodology has been carefully chosen. Also, the thesis surveys substantial amount of relevant literature, but still, the part on literature review is nice to read and I believe Michal was able to summarize the main issues and the main challenges in research on determinants of economic growth.

Furthermore, let me add that this thesis has also potential for being published e.g. for rigorous exams, but some additional work has to be done. In particular, it could be interesting to recalculate the empirical exercise for other dependent variable including the current GDP or GDP growth between 1995-2015, just to see whether the cultural variables do have any predictive power in explaining the future economic growth. Additionally, Michal shall be more explicit in several aspects of his empirical exercise, for example, why just 46 countries are covered (and not more).

All in all, I consider this thesis as a nice piece of work and I believe Michal Frydrych demonstrated his knowledge of the current literature and up-to-date empirical methods so my final recommendation points to grade A, excellent.
