OVERALL ASSESSMENT (provided in English, Czech, or Slovak):

The Bachelor thesis presents an empirical research focused the Irish housing market. The author applies the recent work by Kouwenberg and Zwinkels (2014) originally developed for the US market and he further extends it to the needs of Ireland. The thesis is very well motivated with a clear contribution to the existing literature in terms of both methods and application.

The thesis has a clear structure; it provides a concise literature overview and relevant stylized facts also documenting the long-term trends of the Irish economy and its housing market that is currently one of the very attractive research topics. Importantly, Jiri demonstrates his ability to familiarize himself with the heterogeneous agent model (HAM) methodology and skilfully applies it to the case of Ireland. The author further proposes extensions by looking into the exponentially weighted moving average (EWMA) approximation and compares the results with other fundamental value approximation strategies. The hypotheses, tests and estimation results are clearly presented and discussed. For the defence, I would suggest the author to discuss the comparison of the four presented fundamental value approximations (CMA, SMA, WMA and EWMA).

Overall, I would like congratulate both the student and the supervisor on an excellent output which in my opinion surpasses the standards of the Bachelor theses. As a result, I am very pleased to **recommnd the thesis to be defended and awarded the grade "excellent" (1).**
