Contribution

The goal of the thesis is to design pairs trading strategy which would prove profitable at CEE markets (Prague Stock Exchange, Bucharest Stock Exchange and Budapest Stock Exchange).

The main contribution of the paper is the application of two different methodological approaches, method of distance and co-integration, to CEE markets. These markets are specific by lower size, diversity of industries and liquidity compared financial markets in Western Europe or North America where pairs trading was extensively studied and exploited.

Jakub finds that there is no "free lunch" at the CEE markets. By simple application of co-integration or distance method investors cannot **consistently** earn abnormal return at CEE markets.

Methods

Author demonstrates that he got familiar with basic basic time series concepts. He proves that he is able to apply the co-integration and distance method to his research question. He also demonstrates that he is able to work with the methodology of the state of the art literature in the field. In the application of distance method author closely follows Gatve, Goetzmann and Rouwenhorst (2006, Review of Financial Studies). The same paper is also chosen to be a guideline for performance evaluation. Co-integration follows the standard Engle and Granger (1987) approach.

Data are taken from Reuters and some directly from the local exchanges. The data set is split into two sub-samples. First, the formation period is constructed where co-integration and distance method are estimated. The performance evaluation is run then on the second subsample.

Literature

Author provides nice literature review introducing the reader in to the pairs trading and demonstrates that he got familiar with the relevant backround literature.

Manuscript form

The thesis manuscript form fullfills the standards of undergraduate thesis.

Jakub demonstrates that he is familiar with the related literature. The methodology corresponds to the level of bachelor thesis. The arguments in the thesis are clear and comprehensive.
