Contribution

Veronika's thesis a nice example of multidisciplinary study that combines economics with arts management field. The author deals with how visual features of photographs affects their actioned prices. Veronika examines several different approaches on novel dataset, which has been compiled by herself.

Methods

The thesis uses wide range of methods: starting from hedonic regression, model averaging, CART and machine learning classics Random forest. The methods are clearly described and the methodology is easy to read even for non-expert reader.

The conclusions of the study are in line with common expectations, but the impact of auction house location. The place of the auction brings nicely unexpected results and these can be the topic for further research (possibly including more cities).

Literature

Veronika introduces a wide and broad literature review, though the advisor's limited knowledge in this field limits the assessment. One downside is that the bibliography does not split scientific resources from online resources, even though this is purely cosmetic.

Manuscript form

The thesis is of high manuscript quality with slightly different but refreshing layout than the official IES one. Technically speaking, I would suggest recompiling the pdf file for archivation, as there are some poorly readable pages (those containing inserted graphics), which seems to be an issue with typesetting environment. Additionally, the font size of some tables could have been larger (Table 4.9).

Veronika's thesis is meets all the requirements and present a quality multidisciplinary paper, hence I award grade A.
