### **Contribution**

In her bachelor thesis, Anna studies the life satisfaction in the Czech Republic and how it correlates with a rich set of observable characteristics. The thesis contributes to the rich literature focusing on the determinants of life satisfaction by analyzing the data from the context of the Czech Republic in a wider time horizon compared to the existing studies. Further, Anna studies how the strength of the relationship between various observables and life satisfaction has changed over time. The research question as well as the contribution of the thesis is important and clearly defined. The results of the analysis are very interesting, especially the development of the link with age – the results document that as people age their life satisfaction diminishes but at certain age it starts to increase again. Over time, this turning point seems to move towards higher age.

### **Methods**

To perform the analysis, Anna uses appropriate methods which are commonly used to study determinants of life satisfaction. She relies on OLS regressions and in the text she explains what the advantages and disadvantages of this method are. I appreciate that she is well aware of the potential limitations of the analysis, especially the ability to identify causal effects. She clearly points to the limitations and interprets the results carefully as correlations.

### **Literature**

It is obvious that Anna carefully read the related literature and has a good knowledge of it. She provides relevant references to academic research, both in terms of research studying related questions in general, as well as the research focusing specifically on the Czech Republic. Chapter 2 provides a nice literature review.

### **Manuscript form**

The thesis reads very well, the text is clearly structured and the whole thesis very well organized. The graphs and tables are easy to understand.

### **Summary and suggested questions for the discussion during the defense**

To sum up, I believe the thesis fulfills the requirements for a bachelor thesis at IES, Faculty of Social Sciences, Charles University, and suggest grade A.
