Overall Evaluation:

The thesis provides an analysis of the role of industrial relationships and trade unions on the organization and operation of selected European economies. The author applies a fairly recent theory on models of capitalism for evaluation of the often divergent processes and by using several datasets puts forward a critical analysis of the applicability of the theory in explaining socio-economic trends and processes. I recommend the thesis for the defense and suggest grade A ("výborně").

The thesis reviews the development of industrial organization in selected European countries and seeks to see the links in different industrial organization systems may affect labor productivity in these countries. I believe that the author has selected and interesting mix of European countries that enabled her to work with a very varied sample and draw interesting implications. I also appreciate the author's willingness to use some recent theories in an effort to explain fundamental relationships within the industrial organization and innovation processes of firms. On the other hand, I believe that the thesis could have been less descriptive, especially in its first phase (Chapters 3-4) and could be more focused on data analysis with a more structured econometric evaluation of observed processes.

I see the core of the thesis in Chapters 5 and 6 where author presents a comparison and interrelations of labor productivity and union density in the five selected European countries and then provides an explanation for the observed trends within the framework of models of capitalism. Among other interesting findings I would highlight author's explanation of the different volatility of labor productivity in Germany and the UK in Chapter 6 and the way how she tried to explain the trends within other countries that at the first sight contradict the applied theoretical framework.

On the other hand, the author has in my opinion not exhausted the potential of comparing the roles of trade unions in the old and new EU member states. Chapter 2 provides an interesting and fresh insight into the role of trade unions in the new EU member states, yet such analysis is not further elaborated in the remainder of the thesis and Chapter 2 is therefore rather redundant.

The thesis is written in a structured way and a readable language. In addition, I appreciate that the author has tried to use appropriate Czech expressions and translations even for terms and expressions where the Czech taxonomy is not finally settled (especially in the field of the models of capitalisms).

I believe that the author can expand the topic it has analyzed in several ways. There remains scope for the application of more sophisticated econometric methods in an effort to explain the contributions of different factors. In addition, it would certainly be of value if the author applied the applied Western European models to Central and Eastern Europe and tried to examine the relevance of the theory on models of capitalism in a more global scope. However, I believe that the analysis undertaken by author in this thesis provide for a well structured organized paper *per se* and can at the same time serve as a very good basis for
