**OVERALL ASSESSMENT** (provided in English, Czech, or Slovak):

### **Short summary**

The central banks of many countries (especially emerging economies, but with prominent exceptions such as Switzerland and the Czech National Bank) have accumulated massive foreign exchange reserves. It is surprising that these huge reserves have received relatively little attention in the research literature, and even policy materials on this topic are typically brief and vague. Many central banks (including, again, Switzerland and the Czech Republic) accumulate reserves but are not specific about how these reserves can be used to foster the main mandate of the central banks, which is price stability. Because central banks have essentially infinite investment horizons and often rarely sell any portion of their reserves, they have the opportunity to make a lot of money without compromising their main mandate. As far as I know, this thesis is the first research work that carefully examines this possibility.

### Contribution

As I have noted, the thesis brings the first systematic treatment of the possibility of using central bank reserves to obtain yield in the long term. As far as I know, no one has carefully compared university endowment funds and sovereign wealth funds to central bank portfolios. The resulting text is extremely useful for policymakers and anyone who wishes to learn more about the context surrounding FX reserves and their potential use. As such, the thesis fills an important gap in both the research and policy literature. I also note that the author consulted his progress with me on a regular basis and all of my comments have already been incorporated into the thesis.

#### Methods

The predominant method employed in the thesis is case study analysis, but the author also uses VAR to investigate the interplay between reserves and other macroeconomic variables. I think that the econometric and case-study parts of the thesis nicely complement each other.

#### Literature

The related literature is covered very well.
