## **COMMENTARY:**

The Thesis' main aim is to provide analysis of the mutual relations and geopolitical strategies of the United States and the Russian Federation. In particular, the list of goals includes the description of main geopolitical objectives of these two countries; identification of geopolitical strategies they have chosen; analysis of development of bi-lateral relations between the US and Russia during the era of Bush-Putin presidencies; analysis of impact of the "reset" in relations proclaimed during the Obama-Medvedev presidencies (Introduction, p. 1). In addition to that, Jakub Honzík attempts to evaluate the potential cooperation of these two powers (chapter 4.3: "Possible future developments in mutual relations", pp. 74-78). Jakub Honzík aimed to verify the following hypothesis (p. 2): US and Russia have different geopolitical objectives which often contravene each other and will therefore not be able to achieve any significant and durable improvement in bi-lateral relations.

The structure of the Thesis is without major problems. Jakub Honzík used relevant literature, his research is based on text of well-known authors such as B. Lo, L. Shevtsova, A. Kuchins, K.

Barysh, R. Jervis and others. He cites and correctly evaluates works by controversial authors such as A. Dugin.

As his supervisor, I appreciate his ability to work independently and come with interesting ideas. It must be appreciated that Jakub Honzík actually introduced foundations of foreign policies and geopolitical interests of two powers, the US and RF (chapters 2 and 3). The last chapter centers on the author's decent analysis of the US-RF mutual relations as well as potential controversial issues of the so called "reset period".

The above commentary enables me to conclude that the text is fully acceptable as Master thesis - with grade 1 (excellent).
