## **OVERALL ASSESSMENT** (provided in English, Czech, or Slovak):

In general, field of public procurement research has tendency towards weak results, caused by complex institutional setting and poor performance measurability. Main merit of evaluated thesis lays in managing the former and more importantly – eliminating the latter.

By focusing on homogeneous goods, author deliberately restricts himself to field where cost-based benchmarking can be done, in contrary to many other purchases related to provision of public goods. Author is therefore able to use sound econometric analysis and obtain good results – most notably quantifying effect of various institutional settings – though on limited market niche.

To my knowledge, there has been only couple of works in the field which managed to get comparable results, in some respect the work can be even labeled as pioneering. After small revision of econometric part, it should be well publishable in decent journal.

Author has done serious piece of groundwork in gathering and consolidating data from couple of hundreds institutions. More importantly he demonstrated good quantitative skills as well as ability to connect the result with complex reality in public procurement. I therefore propose the grade **excellent**, and suggest to award him with a **distinction**.

### Major comments:

1. At some point, the strict division of analysis into three industry-wise parts is unnecessary. Joint analysis of the data might be fruitful, especially while examining institutional setting, which is common to all three markets, also it would overcome some small-sample problems encountered. Apparently, this would however need serious transformation of whole model, in order to obtain combinable set of variables – most notably transformation of explanatory variable from unit price to relative deviation from market price.

### Minor comments:

1. The form of literature list needs some revision – use of italics, missing publishers, dividing laws, academic and other sources, labeling internet resources..
2. Author frequently refers to CAE as a source ( civic organization, which I happen to be part of), which I did not find explained. Anyway, it would be perhaps preferable to refer to original source of data, with explanatory note that these have been further revised by CAE..
