Content of the Report:

This is one of the best dissertations I have read at the IES FSV UK. At the very beginning I would like to say that I strongly recommend the thesis to be defended without major (actually any) changes.

This dissertation clearly contributes to the existing knowledge in many respects. I will highlight just a few points:

Chapter 2 - The Rose Effect and the Euro: Is the Magic Gone? – provides important policy relevant results on the effect of the euro currency union on international trade. It shows that the euro's trade-promoting effect is insignificant when the publication bias is filtered out.

Chapter 3 – Estimating Vertical Spillovers from FDI nicely systematizes the existing research on vertical spillovers. There are many studies on vertical spillovers leading to different results. Dissertation of Tomáš Havránek shows what explains differences between the spillover estimates.

Similarly, chapter 4 examines horizontal spillovers from FDI using meta-analysis, which allows Havránek explain why estimates of horizontal spillovers differ.

After publication of research of Tomáš I do not see much sense for researchers to continue producing new papers on vertical and horizontal spillovers.

The thesis by being a set of papers using a meta-analysis naturally builds on a huge amount of relevant papers for each topic examined. Tomáš did a great job and included an extremely comprehensive set of papers into his meta-analyses. The same is true regarding literature on technique of meta-analysis. Tomáš Havránek uses state of the art methodology and references it correctly.

As I said at the beginning, this is one of the best dissertations I have seen at the IES and therefore it is for sure defendable at the IES and I am sure it would be defendable at high-quality foreign economic departments.

All the chapters were already published in respected international journals.

I do not see any need in making changes in the dissertation.

Tomáš Havránek answered my comments during pre-defense and provided relevant references on papers where I can find detailed answers on questions raised.

To conclude, I recommend the thesis to be defended without major changes.
