OVERALL ASSESSMENT (provided in English, Czech, or Slovak):

Zdeněk Polák has chosen a highly relevant and up-to-date topic – public procurement of mobile network operators' services. Right from the beginning the thesis states clearly its goal(s) which is to answer nine hypotheses grounded in literature, all dealing with either characteristics of public procurement of this special type of services or final price.

First sections are devoted to the theoretical background, including some basic legal framework and description of the methods and award procedures, which is sufficient, logically structured and introduces the field. I appreciate, that the thesis would be interesting also for non-academic readers as it shows and compares a lot of "unknown" data about the mobile network operators.

There is not much about the thesis that could be criticized, it is a textbook example of OLS analysis, nicely done but not special (in the outstanding meaning of the word). Unfortunately, the sample used is quite small (59 tenders only) however, author is aware of limitations that it brings to the analysis. The results help to understand the bidding behavior of the operators, they confirm some of the hypotheses and disprove others (see page 52).

The author has certainly devoted a significant amount of time to his work and put together a meaningful analysis that gives a nice insight to both telecommunications and public procurement. Therefore, without any doubts, I recommend the thesis to be defended and I suggest the grade excellent.
