Reviewer comments:

References are not in order of appearance in the text (15, 29, 6,...). Many types of errors:

1. Factual errors in text - i.e. Page 10: nine modules turnovers x in text eight only, etc., Page 12, line 12: Primary care is provided by hospitals x line 23: Secondary care is provided by hospitals (What is actually correct?), etc.

2. Typing errors - i.e. Page 12: party x part, etc.

3. Grammar errors - i.e. Page 20 and other: greek x Greek, Page 19: Ministry Finance x Ministry of Finance, etc.

4. Errors in references: Page 18 - incorrect reference No 13 (Law 1745/1987 or 1729/1987?); Page 21 - incorrect reference No 20 (Law 3418/1985 or 3418/2005?); Reference No 8 and 9 are the same (part A and B are from same reference); Reference No 3 - link to websites does not exist; Reference No 16 - date of publication of the article is wrong - not June 13 but June 14; Reference No 28 - incompleted and insufficient - missing information about source (Finantial Times), about date (December 27, 2012), about author (Joshua Chaffin), error in title of article (different); Reference No 30 - error in year of publication (not 1997 but 1985); References No 36, 37 - link to websites are incorrect (and not working) References No 37, 38, 39, 40, 41 - incompleted and insufficient references (missing information about title of documents, articles, missing information about date of publication, etc.).

Missing information about methods and materials used in diploma thesis.

Missing discussion with i.e. the evaluation or limitations of work, own opinion, etc.

Questions:

1. On page 13 is information about limited freedom of choice of doctor by patient. Can you explain this limitation?

2. Is there any obvious borders between social and health insurance system in Greece. Is there only one budget for financing either health care and pension system?

3. On page 13 is remark about informal payment. Can you describe some examples of them? Are any changes preparing in the system?
